

# UPDATE ON RESUMPTION OF FARES FRONT DOOR BOARDING & TOKEN TRANSIT

### **FARES**

Fare collection resumed systemwide on Monday May 3<sup>rd</sup> along with front door boarding.

#### Note:

GCTD's last fare increase was in 2011, since then, reduced fare options have been added for seniors 75+ and veterans, and college students.

#### **HOW TO BUY A PASS**

#### **Fixed-Route**

- Cash on the Bus
- Pre-paid Pass (Magnetic stripe)
- Token Transit Mobile App
- Cash > Text to Mobile NEW

#### **ACCESS**

- Cash on the Bus
- E-Fares (Loaded Value) NEW
- Token Transit Mobile App NEW
- Pass from Organization

### **ECOLANE E-Fares**



# Allows passengers to load value so they don't have to carry paper passes or cash.

#### How it works:

- Passenger calls or visits Customer
   Service Center to purchase a pass
- CSA load value directly to passenger account in Ecolane
- Fare is deducted from balance when they ride




Removes need to hold paper or cash, improving safety and making it easier to ride.

#### **TOKEN TRANSIT**



- GCTD has offered passengers the Token Transit mobile pass option since 2018
- All GCTD fixed-route & ACCESS passes now available for purchase
- Token Transit Fees are based on each pass purchased (funded by LCTOP allocation)
- Growing popularity generated 116K in pass sales growing monthly (until pandemic suspension of fare collection



# PAY AS YOU GO



#### New feature:

Pay-As-You-Go (fare capping) allows riders to ride for free after they have paid the equivalent of a daily or monthly pass.


Each time a pass is activated, Token Transit system scans the passenger's history to see if the capping applies.

If capping applies, the rider will receive the upgraded pass for the remaining amount of time send directly to their app.

After spending \$4.00
Rider receives Day Pass

After spending \$50.00

Rider receives 31-Day Pass



# PAY AS YOU GO Example



David is a frequent rider that afford to pay the upfront cost of a 31-day pass (\$50.00), so he used to purchase two single ride passes (\$3.00) each day.

With Pay As You Go, David begins to ride on June 1, and by June 23rd he has activated \$50.00 worth of eligible passes. Now, When David activates his next pass, it triggers fare capping logic.

Token Transit automatically issues a GCTD 31-day pass as if it were first issued on June 1. This allows him to ride more without worrying about overpaying for the rest of the month.



#### CASH TO DIGITAL PASS



#### New feature for someone...

- without credit card or bank
- wants to send pass to someone else
- doesn't want to enter banking information in the app

# NO CREDIT CARD. NO PROBLEM.

#### How it works:

- 1. Passenger pays for pass at customer service window or over the phone.
- 2. CSA uses the passenger's phone number to send a pass directly to their phone.
- 3. Passenger receives pass for immediate use.



# PASS DESIGN




#### Faster visual validation

- 1. Circle around logo is in motion
- 2. Ticking time of day is current
- Type/quantity of fares is valid


Token Transit is integrated with 3<sup>rd</sup> party apps.
