SUBJECT CONSIDER ADOPTION OF DISADVANTAGED BUSINESS ENTERPRISE (DBE) GOAL FOR FEDERAL FYs 2019-21

I. EXECUTIVE SUMMARY

In 1983 the Board of Directors adopted a Disadvantaged Business Enterprise (DBE) Program. Federal changes in program requirements over the years have been implemented by the Board to maintain compliance. In 1999, the U.S. Department of Transportation (DOT) issued major changes to 49 CFR 26 pertaining to the DBE Program. That regulation expanded the level of attention agencies must provide to meet requirements related to their DBE Programs to continue to be eligible receipt of FTA funds. In 2010, DOT changed the submission of the overall goal from annual to a three-year goal. Then in 2012, DOT required that all DBE Programs must include "Fostering Small Business Participation", which is an element in our program to structure contracting requirements to facilitate competition be small business concerns, taking all reasonable steps to eliminate obstacles to their participation. GCTD's DBE Program has been updated whenever DOT implements changes. There have been no changes to the DOT DBE Program since FY15-18.

The attached "Overall DBE Goal for FYs 2019-21" explains the process by which the proposed DBE goal of 0.5% for Federal FYs 2019-21 was developed. It required analyzing census bureau data, California Department of Transportation's DBE database and GCTD's projected projects. Public participation, and input from DBE related groups and community organizations was also sought.

As part of the required 30-day comment period, the proposed goal was published on June 28, 2018 in the local newspaper, Ventura County Star. The notice invited the public to review the goal and methodology and provide comments within 30 days. The notice was also posted on our website and on public boards located inside and outside of our facility. Upon Board adoption of this goal, staff will review any comments and send them, if any, with the final submission of our overall goal to FTA.

Although FTA has an overall national goal of 10%, there is no minimum goal that must be established or achieved by an agency. GCTD's previous goal for FY15-18 was 1.4%.

IT IS RECOMMENDED that the Board of Directors approve the attached DBE Participation Report and adopt the DBE Goal of 0.5% for Federal FYs 2019-21, to be submitted to FTA.

GOLD COAST TRANSIT DISTRICT OVERALL DBE GOAL FOR FYs 2019-21

I. EXECUTIVE SUMMARY

The U.S. Department of Transportation (DOT) prescribes its Disadvantaged Business Enterprise (DBE) program and requirements for recipients of Federal funds from DOT in the Code of Federal Regulations (CFR) Title 49, Part 26 (Regulations). Specific instructions are found in Section 26.45 entitled "How do recipients set overall goals."

As a recipient of DOT financial assistance via the Federal Transit Administration (FTA), Gold Coast Transit District (GCTD) has established a recommended overall DBE goal for FYs 2019-21 of 0.5% based on all FTA-assisted contracting funds anticipated to be awarded between October 1, 2018 and September 30, 2021.

The goal is based on demonstrable evidence of the availability of ready, willing and able DBEs relative to all businesses ready, willing and able to participate in our FTA-assisted contracts. The overall goal reflects GCTD's determination of the level of DBE participation expected to be achieved absent the effects of discrimination. GCTD intends to meet this goal to the maximum extent feasible through race-neutral measures and does not intend to establish specific goals for any contracts unless needed.

II. DBE GOAL FOR FY 19-21

The proposed <u>overall DBE Goal for FY 19-21 is 0.5%</u>. The goal applies to FTA-funded contracts awarded by GCTD and its sub-recipients from October 1, 2018 through September 30, 2021. The analysis described herein indicates the proposed goal of 0.5% can be achieved entirely through race and gender-neutral measures. In accordance with the decision by the US Court of Appeals for the Ninth Circuit in *Western States Paving Company* v. United States and Washington State Department of Transportation, USDOT recipients in the Ninth Circuit, which includes California, cannot consider the use of a race- or gender-conscious goal unless a finding of statistically significant disparity (disparity study) has been made for the ethnic and gender groups to be included in the race- or gender-conscious goal as part of the overall goal. However, based on the results of the analysis described in sections IV and V of this report, GCTD believes it can achieve the base goal figure calculated in Step One entirely through race- and gender-neutral measures. A summary of disparity studies conducted by Caltrans and the Los Angeles County Metropolitan Transportation Authority is provided in section V of this report.

III. METHODOLOGY FOR SETTING THE OVERALL DBE GOAL

As noted in Section I (Executive Summary), the DBE goal was calculated using the two-step process described in the "Tips for Goal Setting" guidance provided by USDOT. The two-step process for calculating the overall DBE goal is to:

Step 1: Calculate a base figure to determine the relative availability of DBEs; Step 2: Adjust the base figure if necessary.

The DBE Directory and Census Data method was used to calculate the base figure of the relative availability of DBEs to perform the types of contracts that GCTD intend to let. A detailed description of the methodology used in Step One and associated calculations and assumptions are provided in Section IV. In Step Two, past DBE participation and an analysis of bidders (contractors and sub-contractors) and projects from previous years in relation to projects proposed in FY 19-21 was utilized to determine if the base figure should be adjusted. A description of this analysis conducted for Step Two is provided in section V.

Determination of Local Market Area

The boundaries of the local market area were determined by examining the area in which the substantial majority of the contractors and subcontractors that submitted bids and were awarded contracts in past years are located. The location of bidders and firms awarded competitive contracts for the three-year period between FYs 15 through 18 was used to determine the local market area. Because 66% of the bidders and 55% of firms awarded contracts were geographically located in Ventura and Los Angeles Counties, it was determined that the local market area is Ventura and Los Angeles Counties. A summary of the location of bidders is provided below in Exhibit 1, and the location of firms awarded contracts is provided below in Exhibit 2. The names and location of bidders and firms awarded contracts is provided in Attachment 1.

IV. STEP ONE - BASE FIGURE CALCULATION

The purpose of Step One is to determine what percentage DBEs represent of all firms that are ready, willing, and able to compete for USDOT-assisted contracting. This percentage is calculated by dividing the number of DBEs ready, willing and able to bid for the types of work to be funded during a

three-year period, by the number of all firms (DBEs and non-DBEs) ready, willing and able to bid for the types of work to be funded during the same three-year period. The calculation is summarized in the equation below:

Step One-Base Figure = All Firms Ready, Willing and Able DBEs All Firms Ready, Willing and Able (including DBEs and non-DBEs)

To complete the calculation, the first item of work was to develop a list of contracts that GCTD intended to let in FYs 19–21. This list of anticipated projects/contracts is provided in Attachment 2. A total of 20 anticipated contracts were identified that total \$14.2 million.

The DBE firms that are ready, willing and able to perform the anticipated work were identified using the California Unified Certification Program (CUCP) Statewide DBE Directory. DBE firms that indicated their willingness to work in Caltrans District 7 (Ventura and Los Angeles Counties) were selected. North American Industry Classification System (NAICS) codes were then assigned to each project to help identify DBEs and all firms that are ready, willing and able to compete for the anticipated projects. NAICS codes were obtained from the US Census Bureau web page located at: http://www.census.gov/eos/www/naics/.

USDOT recommends that weighting be used to help ensure that the Step One Base Figure is as accurate as possible. Weighting does not change the Base Figure of 0.5%.

The calculations for Step One- Base Figure calculation of 0.5% are shown in Attachment 3.

V. STEP TWO BASE FIGURE ADJUSTMENT

The purpose for Step Two of the goal setting calculation is to adjust the Step One figure to make it more precise, if necessary. The factors listed below were considered to determine whether such an adjustment is necessary:

- Past DBE participation;
- Bidder's List and DBE participation in past contracts;
- Disparity studies conducted in the local market area.

Past DBE Participation

The DBE goals achieved in the previous three federal fiscal years were examined to determine the median DBE participation. The DBE goals achieved in the past three fiscal years are:

FY 14/15 = 1.04% FY 15/16 = 3.37% FY 16/17 = 0.03%

Median = 1.04%

The median DBE participation for the previous three-year period is 1.04%, which further demonstrates that our overall goal of 0.5% is in-line with past performance. The FY15/16 percentage achieved was due, in part, to contracts issued in support of pre-construction activities for the

construction of our new facility. The FY 16/17 percentage achieved was the result of the construction contract not including any DBE subcontractors, as GCTD had anticipated it would.

Bidder's List and DBE Participation in Past Contracts

When comparing bids from previous projects that are comparable to the anticipated projects proposed for FYs 19-21, it is possible that the weighted base figure calculated in Step One can be achieved through race and gender-neutral measures. There is no significant change in the type of projects anticipated by GCTD for FY 19-21.

Disparity Studies Conducted in the Local Market Area

The Los Angeles County Metropolitan Transportation Authority (Metro) conducted a disparity study in 2017 known as the 2017 Disparity Study LA Metro. The study documented a substantially below disparity for White Woman, Black Americans, and Hispanic Americans. It also stated, overall, most groups experienced greater disparities on contracts awarded without goals than on those where DBE goals were applied. All groups, with exception of Subcontinent Asian American-owned businesses, exhibited disparity indices substantially below parity on contracts without DBE goals.

Based on the factors listed above to consider whether to adjust the Base Figure, it is determined that no adjustment should be made. Therefore, the overall goal for FY 19-21 is proposed at 0.5% to be achieved through race and gender-neutral measures.

The calculations for Step Two- Base Figure Adjustment are shown in Attachment 2.

VI. Public Notice and Consultation

The public notice and consultation process conducted for setting the DBE Goal for FY 19-21 is provided in Attachment 4. Copies of all correspondences are incorporated into attachment.

Attachment 4 Public Notice and Consultation

This memo is to summarize the process GCTD followed for public participation regarding its proposed DBE goal for FY 19-21.

DBE Goal Setting Consultation Process

On June 20, 2018, GCTD mailed the "Notice to Disadvantage Business Enterprise Resource and Assistance Agencies" (copy provided below) to the organizations listed in Resource Agency Listing (copy provided below). This letter notified these groups of GCTD's goal, requested consultation and invited them to contact GCTD for a meeting to discuss our DBE Goal.

On June 27, 2018, I spoke with Leigh Kearns, Economic Development Specialist for U.S. Small Business Administration, Los Angeles District Office. She received my letter and wanted to know what her office could do to help us facilitate our program. After a brief discussion of our DBE Programs, she directed me to their website which would allow our staff to query small businesses registered with the SBA for any commodity we are bidding. Our procurement process will now include searching this database to locate SBA sources when we are preparing to go out to bid. This process will also help facilitate the Small Business Element of our DBE Program.

GCTD received no other responses from its letters and no one requested a meeting.

GCTD published its Disadvantaged Business Enterprise Goal on June 28, 2018 in our local paper, Ventura County Star, which is available online and in hardcopy.
