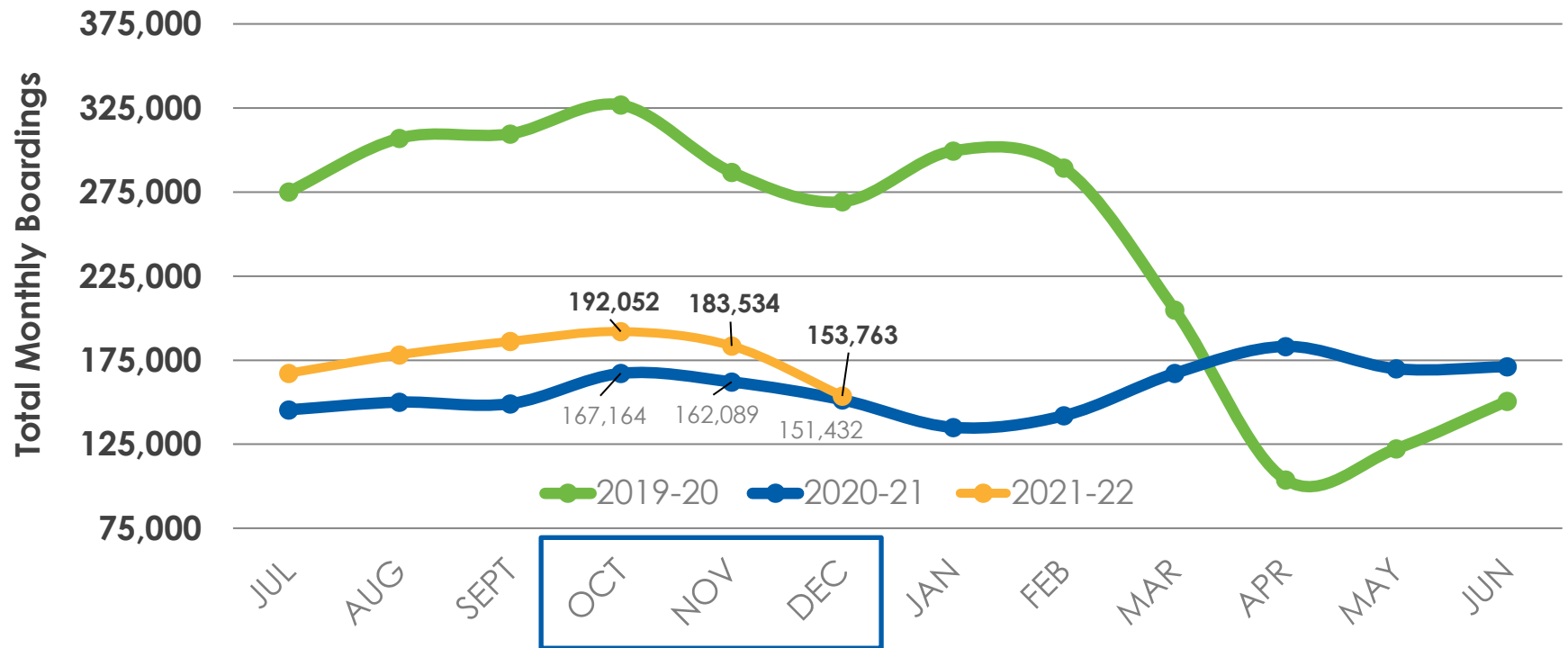

FY 20-21 Quarter 2 Boardings: 480,685

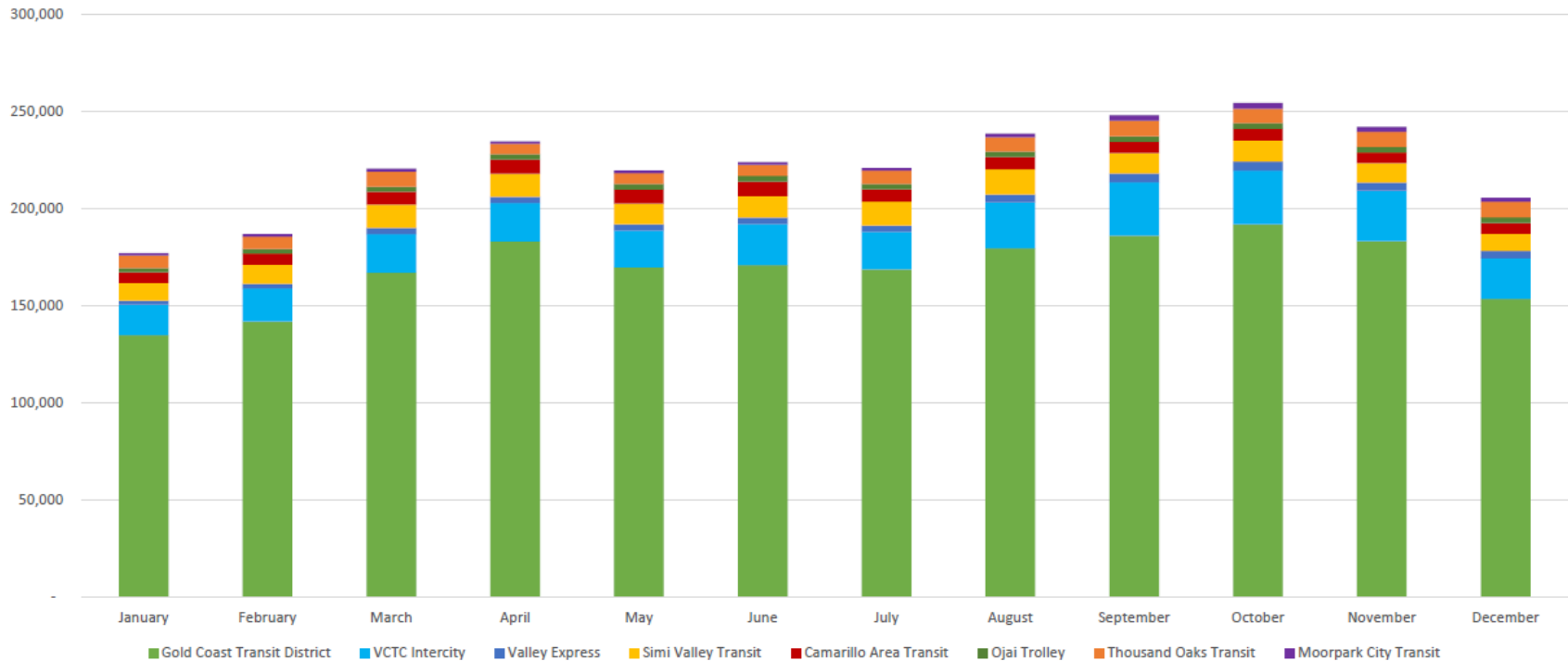

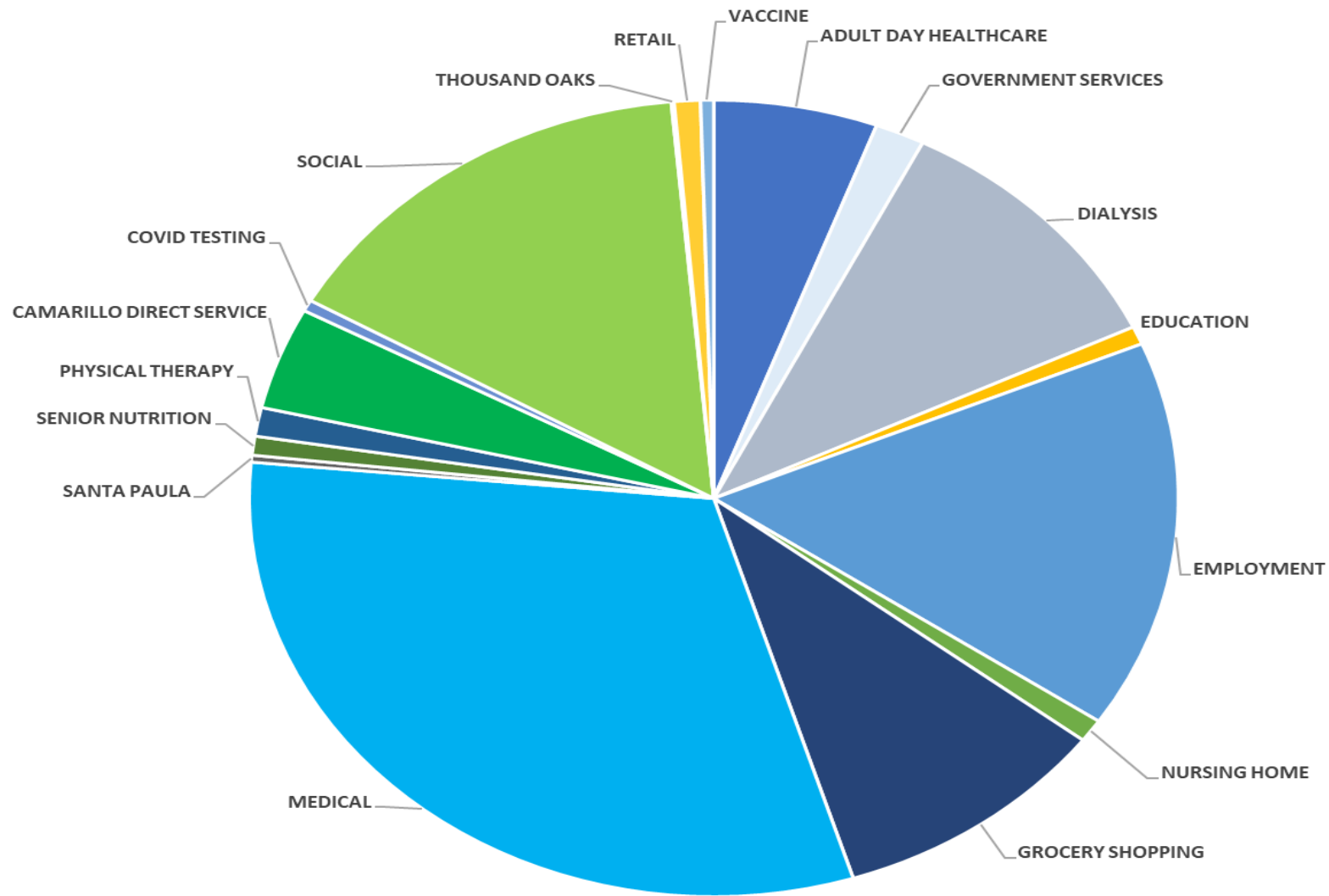
